Dear Local Educational Agency (LEA) ELPAC Coordinator,

This is a reminder that required registration for the 2019–20 English Language Proficiency Assessments for California (ELPAC) Initial ELPAC Administration and Scoring Trainings opens on **Monday, February 4, 2019**.

The Initial ELPAC testing window is July 1, 2019 through June 30, 2020. To prepare for this test administration, there will be 16 spring Initial ELPAC Administration and Scoring Trainings held statewide. The statewide trainings, sponsored by the California Department of Education, will take place from April 15 through May 21, 2019. Ten trainings will be focused on kindergarten through grade twelve, and six trainings will be focused on grades six through twelve. Four make-up trainings will be held in August 2019. Each LEA will only have one seat for a participant to attend an Initial ELPAC Administration and Scoring Training. This training will be a training-of-trainers model. All LEA staff who intend to provide a regional training must also attend the 2019–20 Initial ELPAC training before conducting their own. This training will run from 8 a.m. to 3:30 p.m. and focus on the local scoring of the Initial ELPAC Speaking and Writing domains.

On January 30, 2019, LEA ELPAC coordinators will receive an email containing registration information for their LEA. Please note that due to the limited number of seats at each training, only the LEA ELPAC coordinator will be allowed to register participants for trainings. LEAs may register additional staff to be placed on a waiting list. Wait-listed participants will be notified approximately one week before each training.
